⇒ **U.S. Mail** - allow enough time to be received (**not postmarked**) in the Treasurer's office by February 14, 2025.
 Winter payments **received after** February 14th will be delinquent.

⇒ **Township Drop Box**
 Drop Box is secure and located to the left of the Twp. double entrance doors
 Available 24 hours per day. Do not put cash in the dropbox.

⇒ **In person at the Township Hall - 3755 Pleasant Lake Road, Ann Arbor, MI 48103**
 Office Hours 9:00am-Noon Monday - Thursday, working remotely on Fridays.
 The Dropbox can be used after hours.

*** **CLOSED DATES: Closed December 23-27th, 2024, closed December 31 and January 1, 2025 for New Years**

EXTENDED HOURS Open Monday, December 30, 2024 from 9:00am-5:00pm and Friday, February 14, 2024 from 9:00am-5:00pm.

Please note: **All 2024 dated payments left in the dropbox as of 12/31/24 will be accepted as a 2024 payment.**

⇒ **Any Bank of Ann Arbor Location or Old National Bank, Saline Branch only**
 This option does not require an account with the bank. The bank will take current payments with the bottom remittance of your tax bill during banking hours.

⇒ **Electronic Payments** - payments through our website: www.Loditownshipmi.org : look under township services: tax and assessing.
 The fee for **Electronic Checks is a \$3.00 flat fee**. Electronic checks come out of your checking account.
 Credit Card payments are accepted for a 3% fee of the entire tax bill charged by Point & Pay for processing the transaction.
 Lodi Township does not profit from any of the convenience fees, they are collected by Point & Pay.
