- *INVOICES DUE 30 DAYS AFTER FINAL BILLING
- *UNPAID INVOICES WILL BE SENT TO COLLECTIONS 90 DAYS AFTER ORIGINAL BILLING
- *ANYTHING NOT ON FEE SCHEDULE WILL BE BILLED AT PLANNER CHARGES
- *UNPAID BALANCES MUST BE PAID IN FULL PRIOR TO ANY NEW APPLICATION SUBMITTALS TO THE TOWNSHIP
