All;

I have reviewed the revised Master Deed and Bylaws that I received late last Friday and have these additional comments:

Master Deed

Article II: needs the descriptions of the parcels and parcel numbers filled in. FYI. The acreage for North and South listed seems to be reversed.

Section 3.26 will need to be completed when available.

Section 4.032.1 I assume should be 4.03.2.1.

Section 8.07.1. I am not satisfied with the amended language as I think the proposed language allows future arguments. As the private waste water systems are not permitted in the township and are only being allowed due to the agreement entered by consent judgment, I want the following language added: "The sanitary sewer system and any improvements related to the sanitary sewer system cannot be extended to adjoining property without the consent of Lodi Township and all other applicable governmental agencies."

Section 9.01.4 still needs correcting. Lodi Township is not a charter township. Please delete the word "charter."

Bylaws

Section 2.5.3: reference to Article 6 still seems like it should be to Article 5. Please confirm that you did not intend to change it.

Section 6.22 has been revised from previously and is missing the word "complies." New language should say "...and complies with all applicable..."

Except for the above, I am satisfied with all the changes.

I am writing you to voice my opinions and objections about approving Toll Northeast V Corp's proposed Arbor Preserve developments! If you research them on Google, as I did, you will find that they have TERRIBLE reviews from most of their customers. They are rated 1 out of 5 stars. The people who reviewed them complain about hidden costs, poor construction and construction materials and failures of this company to honor their warranty.
