➡ **U.S. Mail** - allow enough time to be received (**not postmarked**) in the **Treasurer's office** by February 17, 2026 (since February 14th falls on a holiday weekend).
Winter payments **received after** February 17th will be delinquent.

➡ **Township Drop Box**
Drop Box is secure and located to the left of the Twp. double entrance doors
Available 24 hours per day. Do not put cash in the dropbox.

➡ **In person at the Township Hall - 3755 Pleasant Lake Road, Ann Arbor, MI 48103**
Office Hours 9:00am-Noon Monday - Thursday, working remotely on Fridays.
The Dropbox can be used after hours.

➡ **Any Bank of Ann Arbor Location or Old National Bank, Saline Branch only**
This option does not require an account with the bank. The bank will take current payments with the bottom remittance of your tax bill during banking hours.

➡ **Electronic Payments** - payments through our website: www.Loditownshipmi.org : look under township services: tax and assessing.
The fee for **Electronic Checks** is a **\$3.00 flat fee**. Electronic checks come out of your checking account.
Credit Card payments are accepted for a 3% fee of the entire tax bill charged by Point & Pay for processing the transaction.
Lodi Township does not profit from any of the convenience fees, they are collected by Point & Pay.

AS OF MARCH 3, 2026 (Since Feb 28 is on a Saturday): ALL DELINQUENT **SUMMER AND WINTER 2025 TAXES** WILL BE TURNED OVER AS DELINQUENT TO THE **WASHTENAW COUNTY TREASURER'S OFFICE** WITH ADDITIONAL PENALTIES AND INTEREST ADDED BY THE COUNTY ON **MARCH 3, 2026**.
